Early Deadline for Exhibitor Submission and Payment – December 31, 2018

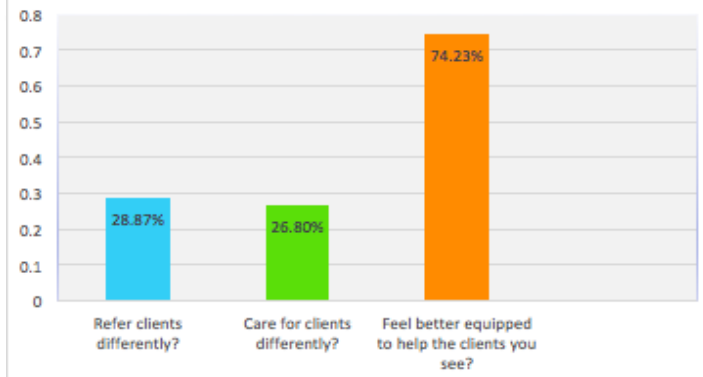
